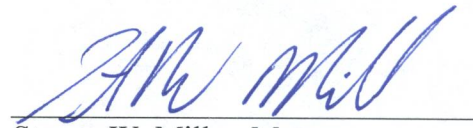

Mayor Miller called the Special Called Meeting to order.

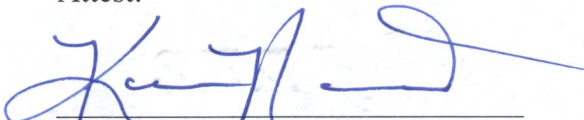
